2. An Expert Team conducted onsite evaluation of the program from 26<sup>th</sup> to 28<sup>th</sup> May, 2023. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the program as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for 3 years. Orissa School of Mining Engineering, Keonjhar, Distt: Keonjhar, Pin:758001, Odisha should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status.


