As per AICTE notification vide F. No.1-101/PGRC/AICTE/Regulation 2019, Dated.07.11.2019 regarding establishment of mechanism for Grievance Redressal regulations, to ensure Transparency in admission, to prevent unfair practices, to provide a mechanism to innocent students to get their grievances redressal etc, every Technical Institute has to appoint an Ombudsman for redressal of grievances on Part-Time basis. The Ombudsman has specific powers and function such as

- 1. The Ombudsman shall hear the appeals from an aggrieved student(s) only after the student has availed all other remedies provided under the regulations.
- 2. While issues of malpractice in the conduct of examination or in process of evaluation may be referred to the Ombudsman. No appeal or application for evaluation or re-totaling of answer sheet from an examination shall be entertained by the Ombudsman unless specific irregularity materially affecting the out come of specific instance or discrimination is
- 3. The Ombudsman may avail assistance of any person as Amicus Curiae, for hearing complaints of alleged discrimination.
- 4. The Ombudsman shall make all efforts to resolve the grievances within a period of 30 days of receiving the appeal from the aggrieved student.

In view of the above, Dr. Gayadhar Das, Retired Professor of D.D. Autonomous College, Keonjhar is reappointed as Ombudsman of OSME, Keonjhar with immediate effect until further orders.
